#### What do I need to do and when?

• If you haven't already, complete your reunion registration form and mail it with your check to Vic Gulliver. The deadline for that is August 1<sup>st</sup>, but do it now if you can.

• Make your hotel reservation by calling 866-358-6255.

• Make your tour choices, make your entrée choices for the banquet, and send that form with your check to Vic Gulliver by August 1<sup>st</sup>. Do it earlier if you can.

Reservations for the reunion should be sent in using the form provided again in this Newsletter. Submit your reservation as soon as you can since plans have to be made based on the size of our reunion group. The cost of the reunion is \$125 per person which should be submitted with your reservation. When you make your <u>hotel</u> reservations, be sure to mention the VP-2 reunion to get our reduced room rate. The Crowne Plaza hotel will guarantee our reserved rooms at our discounted rate of \$112 per night plus taxes up until September 30<sup>th</sup>. After that, our agreed rate will only be offered on a space available basis. See the hotel information regarding the Crowne Plaza Hotel in North Charleston, SC.

If you have already made your reservation to attend the reunion, but only submitted the \$30 per person deposit, the remaining \$95 per person is due by August 1<sup>st</sup>. Send that remainder to Vic Gulliver using the form in this Newsletter

We're now announcing the reunion tours that are planned and the cost of each.

There is a separate form in this Newsletter for you to indicate your tour choices and to calculate your cost for the tours. **On that same form**, you should indicate your entrée choices for the farewell banquet.

The cost of the farewell banquet and the first night's buffet dinner are included in the \$125 reunion fee.

Hotel reservations are the responsibility of each member and can be made by calling the hotel's local reservation phone number: **866-358-6255**. *Be sure to mention that you are attending the VP-2 reunion* to get our lower room rate. Hotel reservations will be taken until September 30, 2014. After that time, reservations at our agreed rate will only be taken on a space available basis.

Our room rate is \$112 per night (single or double) plus state taxes, and can be extended at this rate three days before and three days after our reunion based on room availability. This rate includes a full buffet breakfast (for two guests per room) served each day, Friday through Monday, in our Ready Room.

#### **Other Amenities:**

- Hotel check-in at 4:00 pm. Check-out time is 11:00 am.
- The hotel has its own restaurant, bar, fitness center, ATM, and outdoor swimming pool.

#### Friday, October 31st

We are offering a historic tour of America's best preserved city: Charleston, SC. The cost of this tour is \$46 per person, which includes round-trip transportation, a private guide, admission to Heyward-Washington house, and a visit to the Citadel, tax and gratuity for the tour guide.



#### Depart the Crowne Plaza Hotel at 11:30 am

11:45 am - 1:15 pm: Browse through the Market Square area, well known for its unique shops, boutiques, restaurants and pubs. Enjoy lunch on your own at a place of your choosing in Market Square.

1:15 – 3:15 pm: Enjoy a privately guided bus tour as you explore this enchanting and historic city. Favorite sights include: Rainbow row, cobblestone streets, quaint gardens, hundreds of 18<sup>th</sup> and 19<sup>th</sup> century homes, buildings and churches, and the Battery overlooking the Charleston harbor and Fort Sumter. You will tour the Heyward-Washington house, built in 1772 by Daniel Heyward, father of Thomas Heyward, a signer of the Declaration of Independence. It is the only 18<sup>th</sup> century house open in the city with an original kitchen house, carriage house and "necessary" in the courtyard. The house is furnished with magnificent Charleston-made furniture of the 18<sup>th</sup> century period.

3:15 – 4:30 pm: Arrive at the Citadel, the Military College of South Carolina. Enjoy a Full Dress Parade of the 2000 member Corps of Cadets.

5:00 pm: Arrive back at the Crowne Plaza Hotel.



#### Saturday, November 1st

Today's program includes a full tour of the Boone Hall Plantation in the morning, lunch on our own in the Market Square, and an afternoon harbor cruise to historic Fort Sumter. The cost of this full day's activity is \$85 per person and includes round-trip transportation, a privately guided tour of Boone Hall, escort to the Fort Sumter tour, admission to Boone Hall, admission to Fort Sumter, tax and tour guide gratuity.



#### Depart the Crown Plaza Hotel at 8:30 am

9:00 am - 12:00n: Arrive at Boone Hall Plantation through the famous threequarter mile "Avenue of Oaks." Boone Hall was granted to one of South

Carolina's first settlers, Major John Boone, in 1676. Originally a cotton plantation, Boone Hall spread over 17,000 acres. Hand-made brick and tile were manufactured on the plantation and are identified in the mansion, garden walls, slave cabins and many of Charleston's oldest and most historic buildings. Enjoy a guided tour of the grounds followed by a guided tour of the mansion, a tram tour, and "Exploring the Gullah Culture" of black history in America.

12:30 – 2:00 pm: Lunch on our own in the Charleston Market.

2:30 – 4:45 pm: Board the Fort Sumter sightseeing boat. On April 12, 1861, Fort Sumter was occupied by Union troops who refused to vacate the Fort as demanded by the Confederates. All negotiations finally failed and Confederate batteries in the Charleston harbor commenced a massive bombardment of Fort Sumter, and America's greatest moment of conflict, the "War Between the States," began. The Fort is located at the entrance of Charleston's beautiful harbor. It is only accessible by boat. The Fort boasts an excellent museum containing priceless exhibits. Historians with the National Park Service conduct interesting and informative tours of the Fort. In addition to a visit to Fort Sumter, you will enjoy a complete tour of the Charleston harbor, viewing many points of interest.

5:00 pm: Arrive back at the Crowne Plaza Hotel.



#### Sunday, November 2nd

Our final day of touring includes a morning spent at the Patriot's Point Naval and Maritime Museum with lunch aboard the carrier U.S.S. Yorktown followed by a visit to the Confederate submarine H.L. Hunley. The cost of this tour is \$72 per person, which includes round-trip transportation, admission to Patriot's Point and the Hunley exhibit, plus lunch in the Yorktown CPO mess.

#### Depart the Crowne Plaza Hotel at 9:15 am

9:45 am - 1:00 pm: Explore Patriot's Point Naval and Maritime Museum at our own pace, including the destroyer USS Laffey and submarine USS Clamagore. Tour the USS Yorktown and view the aircraft on display on the Yorktown's flight deck and hangar deck. Visit the Medal of Honor Museum and the mockup of a Vietnam river patrol base. At noon, enjoy lunch in the CPO mess on board the Yorktown.

1:30 -3:00 pm: Tour the Warren Lasche Center where the H.L, Hunley is preserved and on display. Learn the story of how the Hunley became the first submarine to sink a ship in battle when it attacked the warship Housatonic, and how the Hunley crew became victims of their own attack.

3:30 pm: Arrive back at the Crowne Plaza Hotel.

#### How Did We Get to the P8?

In the last issue of the Newsletter, we questioned how we got from the P3 to the P8, and was there ever a P7. Several members provided knowledgeable answers. Bill Kraper's response is provided below:

"In 1976, PMA-240 at NAVAIR released a RFP for a replacement aircraft for the P-3. Lockheed bid a re-winged, re-engined P-3 while Boeing bid a variation of the 737. PMA-240 tried to guide the contract to Boeing as PMA, Class Desk, and Logistics Officer wanted a jet a/c. There was also a complete new avionics package using distributed processing techniques that was state of the art in those days. The avionics package went to Boeing but the airframe ended in protest. During the legal battle, Lockheed had to re-wing 15 A/C to meet Fleet needs and got a jump on the program. Boeing was sure they were going to win and requested nomenclature for the A/C, and OPNAV gave them the designation P-7. Long story short, the avionic package was well over budget and didn't work and was canceled. Lockheed had such a jump with tooling etc. that the new A/C was not affordable and the program became the P3C Update III, but the P-7 designation remained used. And now you know the rest of the story!!!"

#### **Election of Executive Board Members**

At the Charleston reunion, the Association members in attendance will vote to elect a new slate of officers for the Association. Our bylaws direct that the Executive Board consist of a President, First Vice President, Second Vice President, Treasurer and three Directors. Those offices are currently held by Floyd Palmer, Dino Vlahakis, Jim Welch, Doug Donohue, Arley Hamilton, Milt DeBuhr and Vic Gulliver, respectively.

Each of these offices have a four year term, and all of the current officers have served for at least four years. Arley Hamilton and Doug Donohue would like to step down from the board. #### Chaplain's Corner by Doug Millar

Have you ever found yourself "hard aground?" It's a nautical term for running your boat into water that is shallower than the boat's draft, resulting in the boat getting stuck on the bottom – whether it be sand, mud, or rocks.

When I was a young boy, my older brother and I pooled our life savings and bought a 10-foot sailboat for \$60. For the next 60 years I continually had a sailboat of one size or another. During those years my family and I had many experiences on the water — beautiful sails; storms; calms; 3 week cruises into British Columbia; night sails on the Puget Sound; anchoring out in isolated coves; having Orca whales pass directly beneath our boat; many exciting times; some frightening times. Most of it was wonderful, but being "hard aground" was definitely NOT wonderful!

Have I ever run aground? Yes. Most sailors who sail in tidal waters have had the experience - whether they want to admit it or not. Here in the Pacific Northwest, we have huge tidal changes, especially during the summer. It is not uncommon to have a 20 foot difference between high and low tide in these waters. Therefore it is imperative that one carries a set of "Tide Tables" and is proficient in the use of them. Running aground is never fun. It is almost always embarrassing, inconvenient, messy, expensive, and sometimes dangerous. Once the boat hits bottom it usually comes to a very quick halt - throwing people and items around indiscriminately. Immediate action is required to keep the boat from getting even further aground, and ultimately "hard aground." In the case of my grounding, once we hit the sandbar, we instantly tried to spill the wind from the sails; started the engine in an attempt to back the boat off of the bottom. Failing in this, we took a spare anchor in the dinghy and rowed out behind the boat as far as possible – set the anchor in the bottom, returned to the boat with the line to the anchor, and used the winches to manually pull the boat toward the anchor and away from the bottom. Fortunately for us this worked and we were able to extract ourselves from being aground. However, if these steps had failed we would have been left to get "outside" help. The best "outside" help would have been the incoming tide. If we waited, a higher tide would finally come and the boat would float off of the bottom and we could return to deeper water.

Due to our ages, all of us VP-2ers are moving into life's uncharted waters. We don't know when we may encounter any number of fear inducing experiences, but we know that they are certainly out there waiting under the surface for us. They may be health issues; possible financial problems; losses of spouses or other loved ones; difficulties for our children or grandchildren. And likely - pain and suffering. Just as we prepare to avoid running aground while boating, we need to prepare as best as we can for the unknowns that are ahead. If we aren't already doing so, we need to get proficient with our "tide tables for life," God's word - the Bible. Try to get into it every day, at the same time establishing a relationship with the Lord through daily prayer. It is not too late to start, and if you have never spent any serious time reading the Bible I would suggest that you start in the New Testament book of Mark and read through from there. Then, when we hit the uncharted shoals of life and need that "outside help" from God, we will be able to endure whatever we face with God's joy and peace. Here is a passage from Philippians, chapter 4, which I have memorized. It has been very helpful to me in the past and continues to encourage me presently: "Don't worry about anything; instead, pray about everything. Tell God what you need, and thank Him for all He has done. If you do this, you will experience God's peace, which is far more wonderful than the human mind can understand. His peace will guard your hearts and minds as you live in Christ Jesus."

You may be thinking, "I'm not interested, Doug. I'm the captain of my own ship. I'll be fine!" If so, sail on. But beware of danger ahead. God has not promised us tomorrow. All we can be sure of is - this present moment.

Have a great summer. I hope to see you in Charleston in October.
