Planning has begun for San Diego *by Greg Kelley*

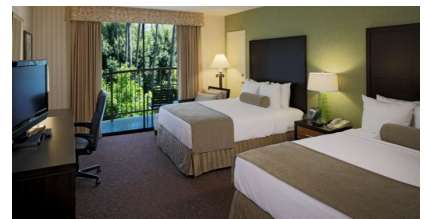

The reunion will be at the Crown Plaza San Diego—Mission Valley Hotel, 2210 Hotel Circle North, San Diego, Thursday, October 18 - Sunday October 21, 2018. Monday, October 22, is the check out day. The Crown Plaza is



a four star hotel with many amenities. Full details for making hotel reservations and signing up for tours will be in the fall newsletter. That newsletter will provide the costs and have the tours that will be planned. As in the past, we are working to make the reunion as affordable as possible. The room rate is \$129 plus tax single or double. This will include breakfast. You may make reservations beginning in December .

What is Armed Forces Reunion and who is Ted Dey?

After researching various reunion planners, your Executive Committee selected Armed Forces Reunion in Norfolk VA. This organization was founded by Ted Dey in 1988 and has an excellent reputation. As the name suggests, Ted specializes in reunions for military organizations. Recent reunions have been for Army Chaplains, USS Memphis, and USS Missouri, and the A6 Intruder Association.

One difference this year is that registration will be through Armed Forces Reunion and will cover the regular registration as well as any tours you select. This can be on line or by mail. The registration and tour information will be in the December Newsletter. We expect the registration will include the same items as past reunions. That includes welcome reception, closing banquet, ready room and incidental costs, as well as the fee for the planner.. We expect the fee will be in line with the past three or four reunions. We will have the exact number in the December newsletter.

Things to do in San Diego

San Diego is a wonderful city, as most of us know. Many of us served at least a few months there at NAS North Island. There are many things to do and some are highlighted here. These may or may not be on one of the tours that are offered.



The San Diego Zoo is world famous and located in Balboa Park. It has over 3700 animals of 650 species and sub species. It is located near the Crown Plaza.

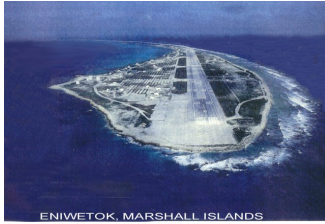
Other popular activities are the daytime cruises around San Diego Bay. Dinner in the Gas Light area, which has many fine restaurants, is another thing to consider.

VP 2 at Eniwetok Atoll



Ken Price submitted this. This is an interesting chapter in VP 2 History and an opportunity to learn more about Ken.

I was born and raised in Goose Creek, TX, now Baytown, and left in 1951 to join the Navy.

I am a one year member of the VP-2 Association and would like to share a bit of VP-2 history. In 1951 I joined the Navy right out of High School as the Korean War was on and the Army was still drafting guys as soon as they graduated. After Boot Camp, A and P Schools I was assigned to VP-2 on an island I had never heard of but as a new Tin Bender, ready to do my part.

In the Fall of 1952, VP-2 was deployed with 12 P2V-5's to the Atoll of Kwajalein in the Marshall islands for the first Hydrogen Bomb Test at the Atoll of Eniwetok. (up close to Bikini Atoll where the Atom Bomb Test were conducted) We were already there when the U.S. Air Force arrived with B-50's, C-124's and a B-36. They took almost all of the Ramp Parking so our 12 aircraft were pushed to the very end of the runway. The B-50's were to fly through the Hydrogen cloud to collect air samples in square boxes fixed to the top of the fuselage. VP-2's job was to fly Barrier Patrols and warn shipping to vacate the area. Good idea but difficult to accomplish, especially the Japanese Fishing Boats who were almost impossible to communicate with but we tried.

I believe the tests were called "OPERATION IVY" and lasted about two months. It was an interesting deployment and we were back at Whidbey for Christmas and then off to Kodiak in January. Typical Military operation, from 112 degrees each day to below freezing each day. But quite an adventure for a 19 year old Kid.

Editor's Note on Operation IVY. (from Wikipedia)

Operation Ivy was the eighth series of American nuclear tests, coming after Tumbler-Snapper and before Upshot-Knothole. Its purpose was to help upgrade the U.S. arsenal of nuclear weapons in response to the Soviet nuclear weapons program The two explosions were staged in late 1952 at Eniwetok Atoll in the Pacific Proving Ground in the Marshall Islands.

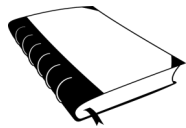

Chaplain's Corner *by Doug Millar*

Hello, again. I have been on a journey recently that has been something entirely new to me, - it is called "elective" surgery. If I understand the term properly it means that you can select for yourself whether or not you want to have the surgery. If you don't want to try it, you can just put up with whatever your particular ailment is in its present form. Or if you want, you can accept the surgery and hope that it will make things better for you in the future than they have been in the past. As I write this in April, it has been exactly two weeks since I had total left knee replacement surgery. I must confess that at certain times during these last two weeks I have considered that I clearly had lost my mind in saying "yes." It is the kind of situation where you gather the facts beforehand, evaluate the pros and cons of the matter, anticipate the results - and make your choice. Once done it is done, and then we look for affirming testimonies from those who have done this before us, and who give us glowing reports of their outcomes. I would have to say that it is clearly a matter of faith - faith that the future outcome will be better than the present situation, even though we cannot be sure of how it will turn out.

While housebound for these few weeks of recovery, I have had a chance to think some about the similarities and differences between this elective surgery choice and the matter of our Christian faith in Christ for our salvation and eternal life. It seems that some of the similarities are: (1) we need to realize that we have a problem; (2) we need to hear that there is a solution to the problem; (3)

it helps to hear accounts from others who have tested the solution; (4) we need to make our own choice as to what we will believe; (5) and finally we need to invest ourselves in the decision that we come to. As to what is different: with elective surgery we cannot be guaranteed what the results will be, but when we choose to accept Christ and His offer to us of forgiveness for our past and future sins, and for everlasting life with Him - we can have the assurance that this is exactly what will happen. It is a done deal!

With elective surgery we have a hope that all will turn out well. With Christian faith and acceptance we have assurance - rather than just a kind of wishing hope. Hebrews 11:1 says, "**Now faith is the assurance of things hoped for, the conviction of things not seen.**" The reason for this assurance is that our forgiveness and future life with Christ has been bought and paid for by two things - the substitutionary death of Christ for our sins; and His resurrection from the grave - which verifies all of His claims to divinity, as well as His promises made to those who will follow Him. I Corinthians 6:19 says, "**Do you not know that ... you are not your own? For you have been bought with a price: therefore glorify God in your body.**" You have been bought and paid for by Christ. The matter has been settled in Heaven.
